Pole Vault Membership Information

Gold Membership (Annual Membership):

- \$200/month, commit to 12 months per year
- First priority for checking out poles
- Athlete commits to the prescribed 5 day/week workout for 12 months. If the athlete is unable to be at the Den 5 days each week the workout may be done on their own.

Silver Membership (Monthly Membership):

- \$200/month, commit to 1 to 11 months per year
- 2nd priority for checking out poles

Bronze Membership (Daily Membership):

- \$45 daily fee, paid prior to practicing
- Pole checkout applies only after Gold and Silver athletes pole selections are complete
